# 7.0 Reports from County Cllr, District Cllrs and Parish Cllrs

#### **District Councillors**

#### **Cllr Harding**

- Attended TDC's Full Council Meeting 13/12/2021, where the budget for the leisure service takeover (Torridge Active) was discussed. This will start from the 1st April 2022, with a full appraisal to assess the way forward on the 22nd September 2022.
- TDC is hoping to acquire land at Gammaton Road, which will be used to relocate the kerbside recycling and waste services, moving them from Appledore and Westcombe Lane (Bideford).
- TDC Officers are now working from home.
- In terms of Parish, Cllr Harding apologised for not being able to help with the tree. It was noted it was good to see light on at the new affordable homes. He asked if the Parish Council would write a letter to the Hall Committee congratulating them on the affordable housing.

#### **Parish Councillors**

#### **Councillor S Raffe**

- Thanked Cllr Heywood for erecting the tree and lights.
- Back Street The drain cover on the unsurfaced area as a deep dent in it. A new cover is required. ACTION: The Clerk to inform MXB and Highways.

#### **Councillor L Spittles**

- Circulated a leaflet on the proposed Solar Farm at Limebury. There was a presentation at Bucks
  Cross Village Hall 14/12/2021, but not many attended as it was not advertised well. They are at
  the planning stage, and although in Parkham Parish will affect Bucks Cross.
- Following the recent storms there was a lot of destruction, with cars damaged, trees down, slates and power was lost. It was asked whether Highways or the Woodland Trust could conduct a survey of the trees and there are many lying on wires, etc. **ACTION: The Clerk to write to Highways and the Woodland Trust.**

#### **Councillor S Salvidant**

 A dog walker reported that there was a large bull on the coast path between Bucks Mills and Peppercombe. Who do people inform should this happen again? ACTION: The Clerk to establish who is responsible for the Coast Path and who would walkers contact.

#### **Decisions & Appeals – FYI**

**Update from TDC re Mr Fletchers Mobile Home** - Email received from TDC Enforcement Office states that there is an open enforcement investigation, E/08/021/UDRY, on the above land and as such there is limited information that I can be provided. However, the case remains open and will be progressed as soon as practicable.

It was questioned why this was taking so long and the reasons why information cannot be shared. Following discussion it was agreed to submit a request under the Freedom of Information Act, requesting

correspondence relating to planning application 1/0687/2010/FUL, between TDC planning and the applicant. Specify a deadline. **ACTION: The Clerk to submit a FOI.** 

**1/0410/2021/FUL** - Proposed new bakery and public space, along with new garden enclose for Hillside. Land adjacent to Post Office and Store, Chapel Street, Woolsery. **Application granted**

- In terms of finger posts, Highways had previously stated that the new signs rejected were not up to specification. It was questioned whether these were ever replaced. **ACTION: The Clerk to write to Highways.**

#### **Bucks Cross.**

- a. Bucks Mills Signs 1) "Slow Down, Sharp Bend" and 2) No Parking in the Village. ACTION: The Clerk to write to Highways to ask if they can erect a sign that says "No Through Road, Access Only".
- Bucks Mills Waterfall sign, response from TDC ACTION: The Clerk to liaise with Mark Beer TDC, emphasising that the Council has a duty of care to make sure people are aware the waterfall is polluted.

# **Road Closures**

**4th - 12th January 2022-** Road from Fernlea to Auction Way. Works to excavate and lay new U/G electricity cable to supply new works to include network reinforcement.

**7th - 11th February 2022 -** Road from Cranford Bridge to Farmers Arms. Closed to allow excavate of trench from electric pole.

**28th February - 4th March 2022 -** Stroxworthy Cross to Alminstone Cross. Kier on behalf of SWW to disconnect the supply.

Cllr Hill has made contact with the new Housing Enabling Officer at TDC as well as Sam Novak (Westward Housing) who will be moving this forward in the New Year.

## 13. <u>Update from MXB Sub-Committee</u>

Met prior to the Parish Council, main points raised:

- Whilst the planning application for the Bakery has been approved, MXB are in discussions with TDC regarding the opening hours.
- Discussed the planning application and the need to submit a Scail assessment for Natural England.
- The drilling rig is required to do the ground source heat pumps, and will be delivered next week. It will be onsite for approximately 6 weeks starting in January 2022.
- The scaffolding has been taken down on the Old Smithy.
- Still waiting for a date for the ship refit.
- At the farm the potting shed continues with interiors, with the machinery shed near completion. The works on the gates and lights, etc, will start until Spring 2022.
- In terms of lighting on the fencing by the Manor, Highways have stated that only reflectors can be used, not lighting.
- Rather than charity boxes in the shop, MXB has decided to have a charity per month, agreeing
  to match fund any donations. December is in memory of Clive Leonard, with funds going to
  Devon Air Ambulance, January 1st Woolsery Scouts and February will be the Samaritans. If
  there is a charity that operates in or benefits the Parish, they can contact Emily Harmon at MXB.

#### **Woolsery**

- a. BT Payphone and Installation of a Defib / Electricity for Bus Shelter The response on Facebook was for a defib. Stats from BT highlighted that the payphone has been used 8 times in the last 12 months. Following discussion it was agreed to obtain further data from BT, in terms of when it was last used, and of those calls were any emergencies. **ACTION: The Clerk to write to BT.**
- b. Pre-Planning Fee £100 & Quote for Bus Shelter & Installation Work Copper Hill Cllr Rafe has visited the site, stating that footings are in the bank, therefore potential for a bus shelter. **ACTION: To take measurements of the area.**

#### **Bucks Cross**

a. Quote for Slats and a Bench by the Bus Stop - Unfortunately the Parish Council does not have the budget to support the quote submitted. **ACTION:** Parish Cllrs to look at options regarding the slats, but agreed to put the bench on hold.
