Following discussion the Parish Council strongly objects to the planning application for the following reasons:

- There is not a proven need for such a centre in this area and a charity is only proposed to be created after planning is granted.
- Without charitable status it is unclear how the proposal would be financially viable
- The very rural location [11 miles from the nearest town] and the exposed hilltop position of the development is not suited to such a development.
- There is no provision for 24 hr supervision as would be required for animal care and the site would be outside of all guidelines for such a dwelling.
- There is no provision for storage and disposal of waste.
- The bridleway is well used by horse riders and the introduction of use by cars requires a traffic statement

- as stated by DCC Highways.
- The parish council is aware that this proposal is on 1 plot of many that have been advertised for sale having divided fields into small strips. We have concerns of the impact on the surrounding area if such plots are allowed to be developed in a manner such as this.

In principle the Parish Council does not have any objections to a Bakery within the Parish, however the following concerns were raised:

- The location of the site and the lack of parking
- The impact on the Highways within the Parish As requested by DCC Highways a transport assessment or statement is required.
- The Bakery will create a large open space. However, the position of the loading bay does not show the location of the virtual pavement. How will the proposal affect the virtual pavement and pedestrian access, ensuring it remains safe.
- The potential disruption to local residents, caused by location of commercial cooking premises.
- The opening hours of the bakery have not been specified.

It was questioned whether there was a more suitable location owned by the business.
